## **How we will use your information**

The information that you provide on this form will be used to administer your membership of the Club. The information will be used by club coaches and committee members to allow them to:

- apply Club policies including those relating to safety and welfare.
- administer training sessions and provide information about club activities.
- make race entries on your behalf.
- share with you relevant Club and other rowing-related communications.

## **Who else we will share your information with**

- If you wish to compete, we will need to share your name and date of birth with the West of England Amateur Rowing Association (WEARA) so that you can be registered to race.
- We will share anonymised membership data with British Rowing, the National Governing Body and Southwest Lakes Trust as required.

## **How long we will keep your data**

Your information will be kept for the duration of your membership of the club. Your name, telephone number and email address will be retained for a further five years beyond the end of your membership so that we can keep you up to date with Club and other rowing-related activities. You can request cessation of this contact at any time.

## **Your data rights**

- In relation to your personal information, you have the right to;

- request a copy of what we hold about you.
- have it amended if it is incorrect or incomplete.
- have it deleted (where we do not have a legal right to retain it).
- withdraw your consent if you no longer wish us to process it.
